Janssen recommended staff work with Building Inspections, Engineering, and Stormwater Utility to do outreach with nuisance properties (due to pumping) regarding the Floodplain Relief Program. Conroy is willing to walk homeowners through the City grant and loan process, and mentioned classes that grantees from the replacement housing program have to attend. Additional outreach suggested includes informational

Conroy said basement infill projects had cost of \$47k and estimated \$46k for another house; suggested coupling with housing rehabilitation loan from City. There was a comment from the public that not all Floodplain Relief Program applicants may qualify for the Housing Rehabilitation Program.

Padesky motioned to raise the grant amount to \$25,000, Janssen seconded. The motion carried by a voice vote. Staff will draft resolution for Council introduction.
