<u>20-0913</u> Temporary Demonstration Project Options:

A motion was made by Gallager, seconded by Loehr, that Option 2 and 4 with alterations as follows be adopted as temporary demonstration projects. Alterations to existing options as follows: Option 2: Curb extensions/neckdowns (changed to pedestrian island) at Northside Elementary School at Kane and Charles Streets, in front of school entrances. Curb extensions (changed to pedestrian island) onto Gillette Street at both Kane and Charles Streets. Option 4: 8th Street neighborhood greenway between Johnson and Ferry, (changed to Adams to Cass St.)

Survey Results - Sonia Dubielzig-Haeckel

Sonia from Toole Design discussed the feedback provided by the survey/public input tool. She highlighted several reoccurring themes that emerged as follows:

- •Curb extensions are controversial in La Crosse. Seven people wrote they do not like curb extensions because they create conflicts between bikes and motor vehicles. Some referenced the curb extensions on Cass Street, which were designed poorly and extend too far out into the street to allow for a bicycle lane. However, four people did agree with some of the curb extensions recommendations.
- •Five people wanted to see more recommendations for protected bike lanes. In particular, some called for road reconfiguration on Losey Boulevard to accommodate protected bike lanes. Toole Design staff will take a closer look at Losey Boulevard to see if it may be within the traffic volume threshold for removing vehicle lanes.
- •Eight people wanted to see more enforcement recommendations, such as enforcing around schools, speed limits, and four-way stop intersections.
