Meehan brought up the GHG inventory scopes 1-3 and explained what they cover. Staff said the 2019 GHG inventory covered municipal and community emissions in

scope 1 and 2, because 3 is very difficult to ascertain. Van Maren suggested the GHG inventory should cover all 3. Van Maren also asked when the plan is anticipated to be completed and emphasized the urgency of moving quickly.

Lenard motioned to approve, Meehan seconded. The motion carried by a voice vote.

Intern and staff presented memos recommending changes to Strategic Plan for Sustainability goals. On the green business certification memo, Van Maren asked if any case studies had actions that worked against sustainability goals. CM Mindell asked if the certification could include cultural and ability sensitivity to reduce unintended consequences. For the LEED requirements memo, Meehan suggested considering the Living Building Challenge. Lenard said requirement was excluded from Strategic Plan to avoid cost of certification. Mayor Reynolds supported less emphasis on certification and not getting wrapped up in outside measures; do what is extraordinary for La Crosse. Van Maren suggested considering Net Zero Energy Buildings. For the carpooling memo, Van Maren suggested free park and ride at edge of city and reduced fare transit passes. For community garden recommendations, Van Maren emphasized the cultural change need for "food not lawns." She also suggested broadening the idea of a garden to include rain gardens and pollinator gardens.
