<u>21-1052</u> Discussion of the accessibility and safety concerns at the George Street/West George Street intersection with a WI DOT representative

The Committee detailed concerns they had at the intersection of George and North George St. to Francis Schelfhout the Wisconsin DOT Bicycle and Pedestrian Coordinator. They were concerned with an uncontrolled intersection crossing of the bypass right turn lanes (from the sidewalk on George St) to get to the area at which you could press the button to trigger the pedestrian activated lights to cross the intersection. This uncontrolled crossing presented a difficulty for people with visual or mobility disabilities. Francis Schelfout acknowledged that "sharks teeth" pavement markings and yield to pedestrians signs could be added and would consider RRFB or a crossing arrows. Chairman Nylander asked the Francis to report back on these concerns at the next Committee for Citizens with Disabilities meeting.
