Motion made by Neumeister, seconded by Schoenfeld, to APPROVE the following amendments:

- Item #624, Flood Levee Rehabilitation, reduce 2022 funding to \$100,000 and reduce 2023 funding to \$500,000.
- Item #168, Pamel Creek Repairs, reduce 2022 funding to \$0.
- Item #758, Renew the Block Project, change the 2022 funding \$35,000 for Storm Water Utility. Organization should request remaining balance though ARPA funding.
- Item #649, Bliss Road Slope Stabilization, change 2022 funding to \$0.
- Item #704, Fiesta Court Median, change 2022 funding from \$30,000 to \$50,000 and change the source of funding to Storm Water Utility.
- Item #507, Waste Water Treatment Plant, change past borrowing to \$68Million and change 2022 and 2023 borrowing to \$0.
- Item #484, Causeway Boulevard Lift Station, move \$1Milion of Sanitary Sewer Utility funding to 2022 to pay for replacement. \$1Million of APRA funds to be included, however has not yet been approved by Common Council.
- Item #564, City Hall Windows, Air Seal Replacement, remove \$200,000 funding for 2022 (Bluff trail funding replaced).
- Item #441, Trails/Bluffland, replaced \$200,000 for 2022 (City Hall window funding exchange).
- Item #134, Saint James Street -- Copeland Avenue to Caledonia Street, move \$287,000 from 2022 to 2023.
- Item #592, Farnam Street -- 10th Street South to West Avenue, move \$302,000 General Obligations from 2023 to 2022.
- Item #178, Liberty Street -- Hayes Street to Moore Street, move \$241,000 General Obligations from 2023 to 2022.
- Item #665, Denton Street -- East Ave to 19th Street, move \$231,000 from 2023 to 2022
- -Item #415, Division Street -- West Avenue to 11th Street, move funding in TID 11 from 2026 to 2022.
- Item #688, Wagon Wheel Connector Trail (TID 11), adjust 5 year schedule back one year so that 2026 will be the final year of funding
- Item #713, 2nd Street Protected Bicycle Lane, move funding up to 2022.
- Item #137, Vine Street -- Front Street to 2nd Street, move to TID 11.
- Item #56, Front Street Realignment & La Crosse St Extension (TID11), move \$500,000 to 2022 fore regrading.
- Item #753, Police Department Remodel, replace \$400,000 in General Obligations for 2022 and add \$200,000 in General Obligations for 2023.
- Item #580, Fire Station #3, replace \$450,000 funding in 2024, \$2Million in 2025 and \$1.4Million in 2026.
- Item #173, Causeway Boulevard -- Dead end West to Copeland Avenue, change \$2.777Million in 2022 from TID 18 via TID 13.
- Item #171, Buchner PI -- Copeland Ave to Dead End West, change \$1.095Million in 2023 from TID 18 via TID 13.
- Increase borrowing level in 2024 to \$17.5Million.
- Increase borrowing level in 2025 to \$17.5Million.
- Remove Item #715, 6th and Badger St Green Space.
- Item #720, King St. Greenway Extension (7th St to the Mississippi River), move funding from 2026 to 2022.
- Item #736, Downtown Neighborhood Association Cass Street Streetscaping Improvements, move funding from 2024 to 2022.
- Item #737, Downtown Neighborhood Association Paint & Fix Up Grant program, move funding from 2024 to 2022.
- Item #714, Lueth Park, move funding from 2024 to 2022.

- Item #745, Pedestrian Lighting - State Street, from 7th Street to West Avenue, move funding to 2024.

Motion passed by voice vote unanimously.

Motion made by Kahlow, seconded by Cherf, to APPROVE the following clarifications of funding sources made by the Engineering Department:

- Item #728, WIS 35 La Crosse Co Line to Garner Place, add \$90,000 in Storm Water Utility for 2022.
- Item #757, Quarry Road Paving End of Milson Court, change 2022 funding from \$100,000 in General Obligations to \$70,000 in General Obligations and \$30,000 in Storm Water Utility.
- Item 665, Denton Street East Avenue to 19th Street, in 2022 add \$30,000 for Sanitary Sewer Operating Funds.

Motion passed by voice vote unanimously.

Motion made by Kahlow, seconded by Neumeister, to RECOMMEND TO THIS ITEM TO BE ADOPTED to the Judiciary & Administrative Committee, with the approved amendments as of today. Motion passed by voice unanimously.
