Mr. Schauf provided a salary and benefits report that will be reflected in the proposed 2022 budget. Recommendations were made by Mr. Schauf based on the results of a recent salary comparability study that was completed on the Housing Authority in June of 2021 by the Nelrod Company - Accuwage Division. The following approvals were voted on: (1) Commissioner Cable moved approval for employees to pay 15% of health insurance premiums in 2022; Commissioner Brown seconded; motion carried 2-0. (2) Commissioner Brown moved approval for an average overall employee salary increase of 3.22% for 2022; Commissioner Cable seconded; motion carried 2-0
