Statement *

I applied for a place with Relax back in Dec. 2021 and was basically ignored by them over the holidays, after seeing one location they had on Caledonia St. I still have yet to see if someone actually moved into that location. Anyway, I have applied for at least two other properties they advertised as available since one in Galesville, WI and a couple in La Crosse, WI and I was not told a thing about my application unless I called them to follow up. last I was told from Susan was they needed proof of income. I sent that via email to them and had to call to see oif they obtained them because I was not told one way or the other. This is after they ask for things like my SS number and date of birth, etc. on rental application. I am pretty sure they are not to ask for that information from potential tenants. Isn't a rental application more like a job application? I think I was discriminated against because I gave them proof of income and explained how if they do a background check or credit history check how I am working with all creditors and on updating bettering my credit report and how I am working with an appellate attorney working with me on resolving unlawful arrest and criminal charges upon me starting 8/30/20. I still had to call and follow up with Relax asking why I was not approved and explained how I have been homeless for so long. I have requested a copy of the record they received because they did say something about my background-check I believe but mostly I believe I was discriminated primarily due to answers to questions they illegally asked on their application and because of the income proof I emailed them, not being from specific source they actually prefer. Besides me having to follow up with them after they requested proof of income, to find out they rented property to another applicant March 1,2022 and I am not the only one out there applying for places to live. As if I did not know that, right?. Bridget A. Karl

Discrimination Complaint Form Information - Draft

The act of discrimination must have happened inside the City of La Crosse and within 180 days of the date the Complaint is filed. It is important that you file within 180 days of the event.

Role of the Human Rights Commission

The La Crosse Human Rights Commission does not adjudicate an outcome to the complaint. Its role is to recommend further investigation of your complaint should it find that the complaint

The complainant and defendant will be invited to attend the HRC's hearing on the complaint. The complainant will have 5-7 minutes to present their case. All Human Rights Commissioners will have received the original complaint and will have had time to review it prior to the presentation. Complainants are encouraged to practice a presentation and anticipate answering questions to provide a description of the most important points in the complaint. Complainants may provide evidence or witnesses with supporting examples of discrimination.

HRC staff can assist with filling out the form, such as reviewing for clarity and content and ensure that the complainant is prepared for the hearing. Staff can also refer complainants to other organizations that can help with completing the complaint form.

Public Hearing

NOTE: Parents are not allowed to make the complaint on behalf of their adult children, except in situations where the parents retain power-of-attorney, guardianship, or guardian ad litem.

If the complainant is not present at the meeting to explain or defend their case, the HRC will not reschedule, but will make a recommendation based on the information they have and the testimony of the individuals present.

PLAINTIFF

Plaintiff will have 5-7 minutes to present their case. All HRC members will have received the original complaint and will have reviewed it prior to the presentation. Plaintiffs should be prepared to succinctly answer the following: What is your complaint? What discrimination do you believe you have experienced? What have you done to try to redress this situation? What do you imagine would be an equitable solution to your complaint?

Defendant

Defendant will have 5-7 minutes to present a rebuttal. They are encouraged to prepare to succinctly answer the following: When did you become aware of the plaintiff's concerns? Why do you believe this complaint is unfounded? What did you do to address the complaint? Describe what you have done to negotiate with the plaintiff. What do you imagine is the best solution to this complaint?
