Description: The Aviation Board oversees matters relating to the operations of La Crosse Municipal Airport.

The Aviation Board consists of seven voting members and up to three non-voting ex officio members. Voting Board members shall be appointed by the mayor for a term of three years. The Mayor's voting board member appointments shall be subject to the confirmation of the Council. Ex-officio members shall be appointed and removed by the Mayor and shall serve a term of two years. One voting member shall be a member of the Common Council and one voting member shall be a member of the County Board of Supervisors. A minimum of four voting members shall be residents of the City. Ex-officio members need not be residents of the City. The Council Member shall be the Chair. The Vice-Chair shall be elected by the body every twenty-four

months on the first regular meeting of the year.
