

2. Project Description

Grey Area Productions will be producing our fifth season, including this Spring production of "Pool (No Water)". This play will expand our interdisciplinary approach to theatre by employing the Meisner Technique, Viewpoints



training, and movement work playing off of an abstract poetic style of language in rehearsal and performance. We consider the productions to be one of our biggest artistic leaps to date and we embrace the opportunity to share a daring, complex, and a truly original story.

"Pool (No Water)" revolves around a famous artist who invites her old friends to her luxurious new home. For one night only, the group is back together. But celebrations come to an abrupt end when the host suffers a horrific accident. As the victim lies in a coma, an almost unthinkable plan starts to take shape: could her suffering be their next work of art? "Pool (No Water)" is a visceral and poetically abrasive play about the fragility of friendship and the jealousy and resentment inspired by success.

"Pool (No Water)" will be a fully staged production. Our needs will include a set, lighting, live music, and choreography as well as costuming and props. A significant time commitment is required from the production team, as well as our actors, to create the quality performances we seek to bring to the community.

While Grey Area Productions provides accessibility to community members through Pay-What-You-Can; donation-based preview performances, Grey Area also provides accessibility to performers, designers, and technicians. La Crosse is a small community when compared to Chicago, New York, and Los Angeles, the home of "working actors", designers, and technicians. There are very few opportunities to receive payment for their craft in our community. Oftentimes, these artists sacrifice hours that could be spent earning a living to be part of a local production.

Since its very first production, Grey Area Productions has paid its practitioners. While payment rates are modest, they are growing with the company. Grant funds would primarily be used to help us pay our actors and production teams for their work, as well as aid in covering licensing rights and additional production-related elements. Small Mouth Sounds will cost \$880 to license (\$110 per performance x 8 performances). The publishing house requires scripts to be purchased for the cast, director, and stage manager. This approximately comes to \$130 for this production.

Overall, our goal for the La Crosse Arts Board Grant is to further build our sustainability and access. Grey Area Productions seeks to offer work that promotes artistic growth and provides bold script selections that enrich the theatre programming in La Crosse.

While every individual production is temporary, Grey Area seeks to remain a permanent part of our region's artistic landscape. We're committed to providing a sustainable environment for our projects.

6. Plans for Removal

7. Target Audience

First, we are fortunate in that The Pump House Regional Arts Center has agreed to help with a portion of our promotion for each production, as per our venue contract. We are included in their mailers, electronic newsletters, and have access to their contact lists.

Additional audience engagement comes from our own grassroots outreach via social media, radio and TV promotion, word of mouth, and poster canvassing.

"Pool (No Water)" provides our audience with an immersive theater experience. The layout of the jewel box theater at the Pump House invites attendees to literally walk through a door into another world. The intimacy of



the space places the audience feet from the actors.

After the performance, we offer Talkbacks with the cast and/or crew to get feedback from the audience and discuss the show they just experienced. This provides a platform for individuals to share with us how successful the desired effect of the production was from a technical standpoint and, more importantly, how the storytelling affected them personally. Our company members have always held the belief that a show is only as good as how much discussion it generates in the car on the way home. This sharing among audience members deepens the experience by illuminating new, varying perspectives.

8. Under-Served Audience (optional)

The foundation of our company is providing accessible theater for all. We are committed to the principle that individuals and families should be able to experience all forms of art regardless of their financial situation.

In keeping with these beliefs, The Arts Board Grant would allow us to further expand our accessibility to audiences by offering a second, "Pay-What-You-Can" donation-based performance. Funding would also help us maintain our lower-than-market ticket price (General Public: \$25.00, Student/Military: \$15).

9. Artistic Goals

This grant will help support our mission to bring local audiences stories that ignite emotion, challenge conception, and inspire growth. Because of our commitment to exploring complex subject matter, our company is seeking this type of funding rather than corporate sponsorship which shies away from difficult-to-categorize artistic pursuits. Themes that we have previously explored include humanism, isolation, multi-generational trauma, political morality, love, death, existentialism, and mental health. We believe La Crosse residents deserve an arena where those who want to can explore these types of themes and ideas without being given concrete answers.

The performing arts get people into a positive controlled setting, where they can feel adventurous, open-minded, and safe. Research supports that in-person group engagement improves mood and decreases depression. As we opened our first show, The Few, in August of 2021 we felt the need to plant the seeds of creative thinking and imaginative problem-solving more than ever. That continues to be true today.

To date, Grey Area Productions has operated under a core company of 5 people. While each production allowed us to invite additional artists, our budget has limited the number of people we can enlist to work on a show. Additional resources and funding would allow us to include more artists and technicians in larger-scale productions that meet our standard of quality.
