

1. Project Location

Creation: Pump House Regional Arts Center, La Crosse, WI Installation: Rivoli Arts District building, 4th Street, downtown La Crosse, WI

2. Project Description

City Sentinel is a large-scale ceramic tile mural that I'm creating in collaboration with Landon Sheely. The mural is made up of hundreds of individually crafted, glazed, and kiln-fired clay tiles arranged in a mosaic style to form a striking image of a bird. Measuring about 8 feet by 8 feet, it will be installed on the exterior wall of the Rivoli Arts District building in downtown La Crosse, facing both the sidewalk and an alley that's planned to be renovated into a more community-friendly public space.

The concept behind City Sentinel focuses on themes of watchfulness, resilience, and connection. The bird symbolizes a quiet guardian of the urban environment, a sentinel observing the flow of community life, nature, and change. Through the handcrafted tiles, I want viewers to engage with both the craft itself and the story it tells. The mosaic technique highlights texture and subtle color variations, reflecting the layered complexity of nature and city life.

The artistic process starts with design and development, followed by forming, glazing, and firing each tile at the Pump House Regional Arts Center. Landon and I will work closely together to make sure the design comes together cohesively and that each tile is crafted with care. After firing, we'll transport and carefully install the tiles on the Rivoli building's wall, turning the space into a permanent public artwork that the community can enjoy every day.

The installation site holds both historical and cultural significance. The Rivoli building is a protected historic structure, which means murals cannot be applied directly to its brick exterior. However, with the support of City Arts Coordinator Jacqueline Marcou, who has consulted with Tim Acklin from the City Planning Department, I have received preliminary approval to mount the mural using a protective layer. This approach will preserve the integrity of the building while allowing for the display of permanent public art.

This project is an important step in my artistic growth, as it allows me to expand from mostly making functional pottery to creating large-scale public art. The mural also supports ongoing efforts to revitalize the Rivoli Arts District and the adjacent alleyway, helping to create a more vibrant and welcoming downtown.

Public visibility is a key part of the project's impact. The creation process at the Pump House will offer informal chances for people to see ceramic art in progress, and once installed, the mural will be a daily sight that encourages reflection on the relationship between art, place, and community.

In summary, City Sentinel is a meaningful project that bridges craft and public art, personal practice, and community engagement. With support from the ARTS Board Creative Development Grant, Landon and I will bring this ambitious work to life, creating a lasting addition to La Crosse's public art scene and inspiring connections between art, nature, and urban life.



3. Project Execution & Timeline

January – March 2026: Design development and tile production. Landon and I will finalize the mural design and begin forming, glazing, and firing the individual tiles at the Pump House Regional Arts Center.

April 2026: Continued tile production, kiln firings, and preparation for installation. We will ensure all tiles are complete and ready for transport.

April 2026: Finalize installation logistics, including securing materials and planning the mounting process.

May 2026: Installation of the mural on the Rivoli Arts District building wall, weather permitting.

June 2026: Public unveiling event and project documentation to celebrate the completion and community engagement.

7. Target Audience

The primary audience includes local residents, visitors to the Rivoli Arts District, and the broader La Crosse community interested in public art and ceramics. They will be engaged through visible public installation, informal studio visits at the Pump House during tile-making, and a public unveiling event. Social media updates and local outreach will keep the community informed and involved throughout the project, encouraging ongoing connection with the mural and its themes.

8. Under-Served Audience (optional)

The mural will be installed in a highly visible, public area of downtown La Crosse, ensuring access for individuals who may not typically engage with gallery-based art, such as low-income residents, youth, and passersby. Its creation at the Pump House also invites informal engagement with the artistic process. By placing handmade, meaningful art directly in a community space, the project makes art more accessible and inclusive to all.

9. Artistic Goals

This project helps me expand my artistic practice by moving from functional pottery to large-scale public art. It allows me to explore new techniques in ceramic mosaics and create a lasting, site-specific work that connects



craft with community. Collaborating with Landon also deepens my creative process and supports my goal of making art that engages and inspires people.




