Project Description – "Survival" Overview

Survival is an original, evening-length dance production that brings together 15–20 dancers to embody the universal human experience of struggle, resilience, and transformation. While inspired by The Hunger Games, this production is not a retelling of a franchise but a visceral, movement-based exploration of what it means to live in survival mode as a human being—and how, through endurance, we can rise as a source of hope for others.

Through contemporary choreography, narrative poetry, and striking visual design, Survival will take audiences on an emotional journey: from fear and scarcity, to resilience and self-discovery, to the emergence of strength and community. The performance is designed to resonate deeply with anyone who has ever felt overwhelmed, hopeless, or stuck in the dark—and to remind them of the power we carry inside to endure and rise again.

Artistic Vision

At its core, Survival is about the human condition. It asks:

What does it feel like to fight for your existence, whether physically, mentally, or emotionally?

How do individuals carry themselves through fear, stress, and anxiety when the odds are against them?

How does resilience turn into strength, and strength into hope?

Movement becomes the language of these questions. The choreography blends contemporary dance, athletic partnering, and ensemble-driven sequences to represent the intensity of survival and the tenderness of transformation. Abstracted gestures—such as reaching, resisting, collapsing, and rising—symbolize the universality of these struggles. Dynamic shifts in tempo, weight, and energy reflect the chaotic push-and-pull of the survival state.

While The Hunger Games offers inspiration for structure and imagery—such as the reaping, the spectacle of power, the struggle of the arena—the production reframes those elements to speak to broader, timeless human themes. The names of characters will not be used in performance; instead, dancers embody archetypes and collective energies: the Innocent, the Fighter, the Companion, the Oppressor, the Hope. This allows the story to be rooted not in one fictional world, but in the shared human journey.

#### Narrative Structure

Survival is a two-act production (two 45-minute halves with a 10-minute intermission) that blends dance with spoken narrative interludes. The narrative poetry serves as connective tissue, guiding the audience's emotional understanding and making the themes relatable to everyday life. For example, before a scene representing fear and scarcity, a spoken voice may share:

"When I was in survival mode, I thought I wouldn't get through it. It was heavy, suffocating, and unrelenting. But even in that place, something inside kept me moving—one step, one breath, one heartbeat closer to hope."

This integration of text and movement helps audiences connect their personal experiences of struggle, anxiety, and resilience with the story being told on stage.



Act I focuses on scarcity, oppression, and the raw state of survival. Scenes move from community hardship to being thrust into survival situations, to the spectacle of being judged, displayed, and tested. Act II shifts into resilience, unity, and transformation. Partnerships and alliances grow. Struggles are faced and overcome. The production ends not in despair, but in a shared rising—an ensemble-driven finale that embodies hope and possibility.

#### Choreographic Approach

The choreography of Survival will draw from several dance vocabularies to highlight contrast and character:

Grounded Contemporary Movement: to reflect struggle, pain, and raw endurance. Heavy, weighted movements like falls, contractions, and floor work emphasize the gravity of survival.

Athletic Partnering: to symbolize dependence, support, and conflict. Lifts, counterbalances, and resist/release phrases embody both the difficulty of carrying others and the beauty of finding strength together.

Stylized Ensemble Work: to highlight systems of power and spectacle. For example, "Capitol-inspired" characters may move in exaggerated, artificial, or stylized gestures, contrasting with the authentic, raw movement of those in survival.

Gesture-Based Storytelling: motifs like reaching, shielding, striking, and rising recur throughout to give the piece a physical language of struggle and hope.

Music will range from cinematic soundscapes to rhythmic, percussive beats and moments of silence—allowing breath and heartbeat to become part of the score.

#### Costume and Design

Costumes will help communicate the contrast between survival and spectacle:

Survival Characters (Districts/Tributes): muted, earth-toned costumes—distressed fabrics, simple silhouettes, practical and raw.

Spectacle Characters (Capitol/Figures of Power): stylized costumes with exaggerated shapes, textures, and colors to show artificiality and excess.

Transformation: as the production progresses, costumes may subtly shift—dancers shedding, layering, or altering their looks to represent resilience and change.

Lighting will emphasize mood shifts: harsh, angular light for moments of oppression; shadow play for fear and secrecy; warm and expansive washes for unity and hope. Minimal but symbolic props (such as fabric strips, ropes, or natural elements like branches and stones) may be incorporated to represent barriers, tools, and transformation.

#### Community and Cast

The cast of Survival will consist of 15–20 dancers. This size allows for large ensemble moments that embody collective struggle and resistance, while also providing opportunities for duets, trios, and solos to highlight individual journeys.

The diversity of dancers—across age, background, and training—will be embraced as part of the storytelling. Each dancer will embody an archetype that reflects different facets of survival: innocence, resistance, strength, fragility, endurance, hope. This layered casting ensures that audiences see themselves reflected in the performance.

#### Audience Impact

The audience experience is at the heart of Survival. While inspired by a popular cultural story (The Hunger Games), the production transcends that reference to speak to universal human truths.

Audience members will leave not only entertained but also moved and reflective. The narrative poetry and visceral movement are designed to spark conversations around:

How do we, as individuals, survive difficult seasons?



How do we carry trauma, stress, and fear?

How do we emerge stronger, and how do we inspire others in their journeys?

The intention is for audience members to see parallels between the struggles of survival depicted on stage and their own lived experiences of overcoming hardship—whether through illness, financial struggle, mental health challenges, or societal pressures. The finale positions survival not as the end goal, but as the doorway to transformation and hope.

#### Relevance and Timeliness

The themes of Survival are especially relevant in today's world. Many individuals and communities have lived through collective survival—global crises, economic hardship, social upheaval. The feelings of anxiety, scarcity, and endurance resonate deeply.

This production offers both reflection and inspiration. By acknowledging the weight of survival while also lifting up the beauty of resilience, Survival creates a space for healing, empathy, and shared hope.

Promotion and Accessibility

For promotional purposes, Survival will be described as:

"An original dance production exploring what it means to endure, struggle, and rise again. Inspired by The Hunger Games, Survival uses movement and narrative to transform hardship into hope."

Promotions will emphasize the universality of the message rather than focusing solely on the cultural inspiration. Performances will be open to all ages, with talkbacks or community discussions offered afterward to invite dialogue about the themes.

Survival is more than a performance—it is a reflection of the human condition. It honors the darkness of survival while lifting up the light of resilience and hope. With 15–20 dancers embodying the journey through movement and narrative, this production offers a powerful, timely, and transformative artistic experience.

By weaving together dance, poetry, design, and universal storytelling, Survival invites audiences not only to witness but to feel the endurance of the human spirit—and to carry that spark of hope into their own lives and communities.

Receiving this grant would directly support my vision of making Survival not only a meaningful production for the audience but also a deeply enriching and accessible opportunity for the dancers themselves.

As a small business owner, I typically ask performers to contribute a small fee to help cover costumes, rehearsal space, and production costs. While this model has allowed us to create in the past, it can also present a barrier to participation. With this grant, my artistic goal is to remove that barrier entirely—to offer this production as a free opportunity for every dancer involved. I want dancers to feel the freedom of creating and performing without financial pressure, focusing instead on their artistry, growth, and collaboration.

Beyond removing participation fees, the grant would help us cover costume design, staging, and other production costs, ensuring the dancers have the highest-quality experience possible. It would also give us the ability to dream bigger: if ticket sales are successful, I would love to take the next step and actually pay my dancers for their work. That has always been my long-term goal—to value dancers not only artistically but also financially for the time, effort, and heart they pour into their craft.

Ultimately, this grant would allow me to align the production with my deeper artistic mission: to create meaningful, story-driven dance experiences that are both accessible and transformative—for performers and audiences alike. Instead of worrying about costs, dancers can step fully into the work, and audiences can witness the purest expression of movement and story. The grant would not only make Survival possible, it would bring us closer to a sustainable model where dancers are honored and supported for the invaluable art they create.
