TO WHOM IT MAY CONCERN:
NOTICE IS HEREBY GIVEN that the Common Council of the City of La Crosse, by its Judiciary & Administration Committee, will hold a public hearing on a proposed ordinance change in the zoning code as follows:

AN ORDINANCE to amend Subsection 115-110 of the Code of Ordinances of the City of La Crosse by transferring certain property from the Multiple Dwelling District to the Traditional Neighborhood District. Specific, allowing for the construction of a multi-family residential building at 518 and 526 10th St. S.

Property is presently: vacant single-family home

Property is proposed to be: multi-family residential building

Rezoning is necessary: to replace underutilized vacant single-family home with 24-unit studio apartment building.
