Prior to the start of construction, all applicable building permits should be obtained from the local authorities having jurisdiction in accordance with local laws and ordinances. You are responsible for complying with state and federal laws concerning construction near or on wetlands, lakes, and streams. DEPARTMENT CONDITIONS:

- 1. This permission is specific to plumbing work, as noted above. Plumbing installations of the remainder of the facility shall not take place prior to the departmental review and conditional approval of the plumbing plans.
- 2. A copy of the plans that were submitted to our agency for which this Permission to Start was issued shall be kept on the jobsite with this letter.
- 3. Interior installations shall terminate a maximum of 18 inches above the floor slab.

- 4. The provisions of SPS 382.21, Testing and Inspection, apply.
- 5. Installations shall comply with requirements for frost protection, crossings, cleanouts, and locating requirements.
