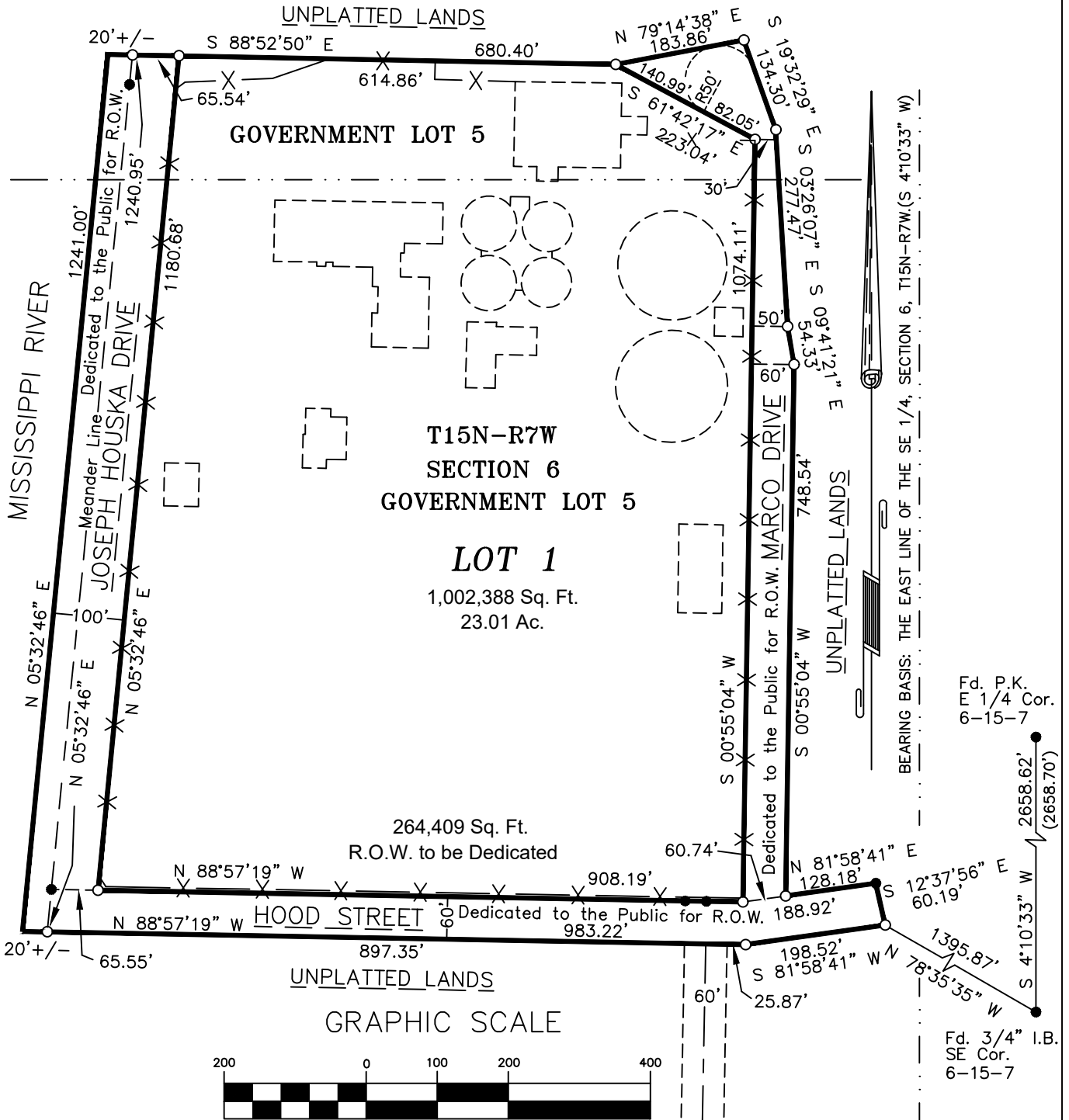

SURVEYOR'S CERTIFICATE

I, Scott M. Dunnum, Professional Land Surveyor, do hereby certify that I have surveyed and mapped this Certified Survey Map located in part of Government Lot 5, Section 6, T15N-R7W, City of La Crosse, La Crosse County, Wisconsin, described as follows:

Commencing at the southeast corner of said Section 6, thence, N 78°35'35" W 1395.87 feet to the southerly right-of-way line of Hood Street, and the point of beginning;
thence, along said right-of-way line, S 81°58'41" W 198.52 feet;
thence, continuing along said right-of-way line, N 88°57'19" W 983.22 feet to a point on the meander line of the Mississippi River;
thence, along said meander line, N 05°32'46" E 1240.95 feet;
thence S 88°52'50" E 680.40 feet to the north right-of-way line of Marco Drive;
thence, along said right-of-way line N 79°14'38" E 183.86 feet to the east right-of-way line of Marco Drive;
thence, along said right-of-way line, S 19°32'29" E 134.30 feet;
thence, continuing along said right-of-way line, S 03°26'07" E 277.47 feet;
thence, continuing along said right-of-way line, S 09°41'21" E 54.33 feet;
thence, continuing along said right-of-way line, S 00°55'04" W 748.54 feet to the north line of Hood Street;
thence, along said north right-of-way line, N 81°58'41" E 128.18 feet;
thence S 12°37'56" E 60.19 feet, to the point of beginning.
