RE: Petition for zoning change at 6103 River Run Rd

Please consider this letter as a request to deny the zoning change proposal at 6103 River Run Rd. The proposal is to change the zoning classification from R2 to TND-General.

We feel that the proposal to change zoning to Traditional Neighborhood Development (TND) conflicts with following Section 115-403 language:

- (a) (1) c--- Provides a mix of uses, including residential, commercial, civic, and open space uses in close proximity to one another within the neighborhood.
- (a) (1) e--- Incorporates a system of relatively narrow, interconnected streets with sidewalks, bikeways, and transit that offer multiple routes for motorists, pedestrians, and bicyclists and provides for the connections of those streets to existing and future developments.

Specifically, the lot involved is not in close proximity to most commercial and/or civic entities and the zoning change proposal does not fix that. With the exception of being able to walk to Southern Bluffs Elementary School, a car is needed to get from our neighborhood to most other city locations. In addition, the nearest bus stop to our neighborhood is on 33rd street. A walk to that bus stop would require the crossing of four lanes of highway traffic (HWY 14/61).

So, it seems to us, that rezoning to a TND does not accomplish what the City is looking for in Traditional Neighborhood Districts. We hope that the council takes all zoning change requests very seriously. We, and many of our neighbors, examined the zoning of this subdivision and took it into consideration when purchasing our homes.

Transit Scores

Transit Score of 6103 River Run Rd is 27/100 (zillow.com)

A Transit Score is a rating that measures how well a specific location is served by public transportation. It's calculated using data from public transit agencies and ranges from 0–100:

- 0-24: Minimal transit, meaning it's possible to get on a bus
- 25-49: Some transit, meaning there are a few nearby public transportation options

Walk Score of 6103 River Run Rd is 0/100 (walkscore,com). 5/100 (Zillow.com)

- 90-100 Walker's Paradise...Daily errands do not require a car
- 70-89 Very Walkable...Most errands can be accomplished on foot
- 50-69 Somewhat Walkable...Some errands can be accomplished on foot
- 25-49 Car-Dependent...Most errands require a car
- 0-24 Car-Dependent...Almost all errands require a car

Bike Score

Bike Score of 6103 River Run Rd is 41/100 (zillow.com)

Bike Score measures whether an area is good for biking based on bike lanes and trails, hills, road connectivity, and destinations.

According to redfin.com, the city of La Crosse, WI has an average Bike Score of 66.
