Please see comments below regarding the proposed Shrine of Our Lady of Guadalupe CSM.

- 1. This proposed Certified Survey Map is subject to La Crosse County Chapter 18 Subdivision & Platting because it is partially located in the Town of Shelby. A \$100 review fee is required along with the County Surveyor approval stamp prior to recording.
- 2. Per La Crosse County Chapter 18 Subdivision & Platting, please add a note that indicates that portions of this parcel are subject to Shoreland and Floodplain Zoning.
- 3. Please add a note indicating why centerline monuments have not been set.
- 4. Please add the length and weight of iron bars that have been set, in the legend.
- 5. Please add a legend on sheet 1 of 11.
- 6. Please show a tie to the W ½ corner of 26-15-7. If shown on sheet 1, please also label the point of beginning.
- 7. Please show a dimension from centerline point to the right-of-way monument on sheet 3 (N end of C45 to N end of C44) and Sheet 5 (W end of L9 to W end of C21 and from S end of C22 to W end of C23).
- 8. Please verify the spelling of the City of La Crosse in Surveyor's Certificate.
- 9. Please verify the dimension in the 9th line of the description, which calls for a distance of 114.86 feet while the curve data for C13 calls for a distance of 114.89 feet.
- 10. Please verify the dimension in the 17th line of the description, which calls for a distance of 534 feet. Please show a distance of 534.00 feet to be consistent with the rest of the distances in the description.
- 11. Please verify the +/- symbol in the Lot 1 area shown on sheets 2, 3, 4, 5, which shows +/E.
- 12. Please verify the 3rd line of the description which currently reads "thence N00°45′09"W 1320.96 feet ". Please consider including "1320.96 feet to the Southeast corner of Roessler Creekside Addition."
- 13. Please verify the 5th line of the description which currently reads "said Roessler Creekside Addition;". Please consider including "said Roessler Creekside Addition <u>and to a meander line of Mormon Coulee Creek.</u>"
- 14. Please verify the data of horizontal curves C3, C4, C7, C9, C13, C30, C31, C40, C41 & C46.
- 15. Please consider further explaining what "lands" mean that are adjacent to the parcel boundary. (unplatted, owned by others, etc.)
- 16. Please consider labeling the ¼ ¼ sections on sheets 3, 4 & 5.
- 17. Please consider labeling the point of beginning on sheet 5 of 11.
- 18. Please consider changing the signature line from "By" to "Authorized Signature" in the Owner's Certificate's on sheet 10.
- 19. La Crosse County records indicate that the NW corner of Sec. 26-15-7 is a 1½" iron pipe.
- 20. La Crosse County records indicate that the E ¼ corner of Sec. 23-15-7 is a 1¼" iron pipe.
- 21. La Crosse County records indicate that the N ¼ corner of Sec. 23-15-7 is a Berntsen Monument.
