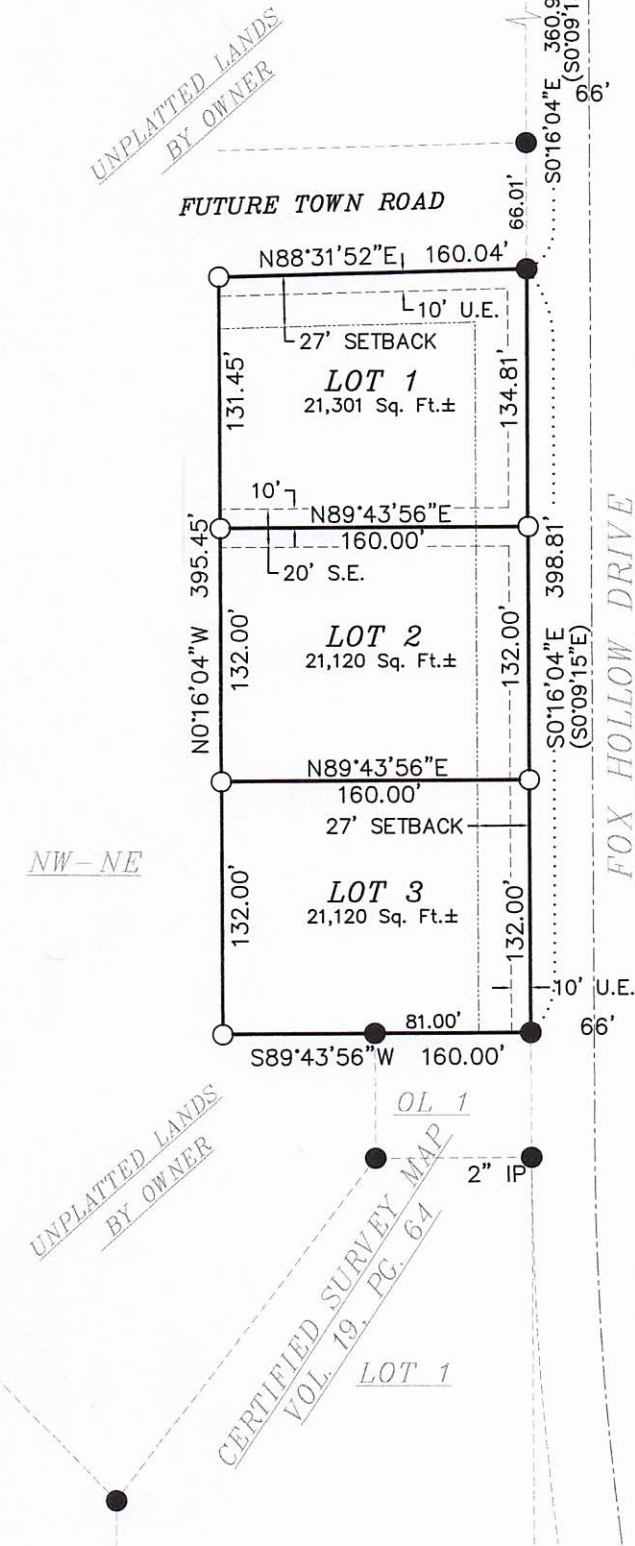

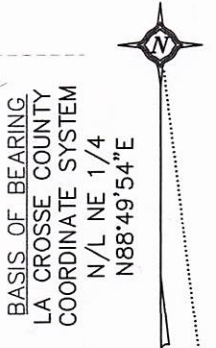
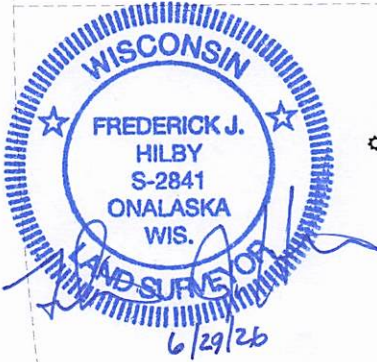


LOT 2

FOX HOLLOW ADDITION

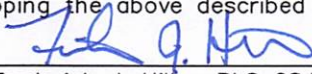
