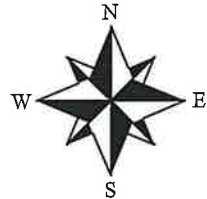


CERTIFIED SURVEY MAP

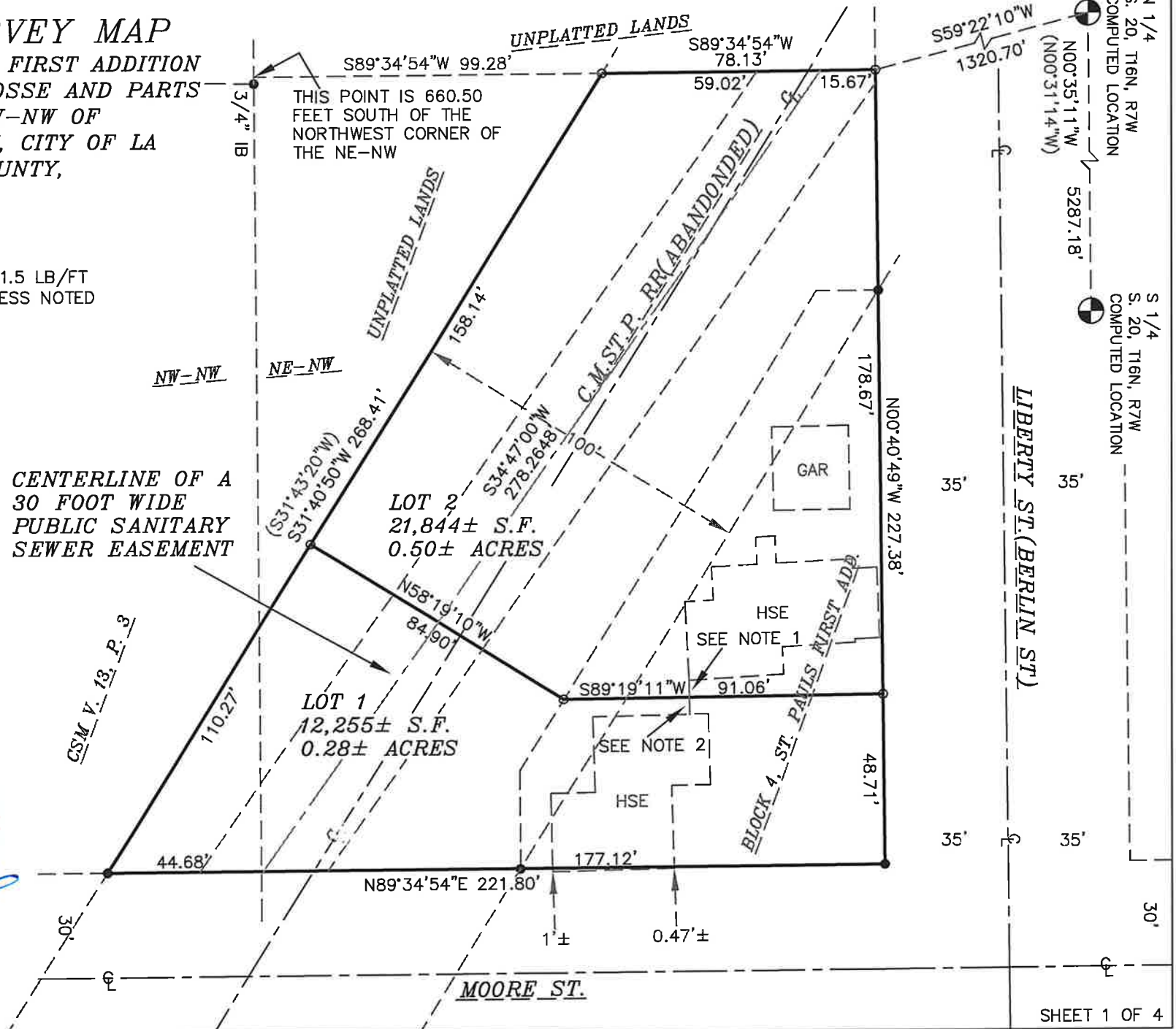

THENCE S31°40'50"W ALONG SAID R/W 268.41 FEET TO THE NORTH LINE OF MOORE STREET;
THENCE N89°34'54"E ALONG SAID NORTH LINE 221.80 FEET TO SAID WEST LINE OF LIBERTY STREET;
THENCE N00°40'49"W 227.38 FEET TO THE POINT OF BEGINNING.
